ACKNOWLEDGEMENT OF RISK AND RELEASE OF LIABILITY

Every person MUST read and understand this waiver before participating in activities

The following waiver of all claims, release from all Liabilities, assumption of all risks and other terms of this agreement are entered into by the "Participant" named below.

- 1) "Activities" includes but is not limited to sports, fitness, functions, use of the facilities, participation in programs, and services provided and,
- 2) I am aware that there are inherent and significant risks ("Risks") associated with participation in the Activities. I am aware that those Risks include but are not limited to the potential for serious personal injury caused by any event or any condition of the facility or equipment. I understand the risk may be relative to my own state of fitness and health (physical, mental and emotional), and to the awareness, care and skill which I conduct myself while participating in the Activities, and
- 3) I freely accept and fully assume all responsibility for the Risks and possibilities of personal injury, death, property damage or loss resulting from my participation in Activities. I agree that although **Orbis Sports Ltd. and Bubble Sports International Ltd.** have taken steps to reduce the Risks and increase safety of the Activities, it is not possible for **Orbis Sports Ltd. and Bubble Sportz International Ltd.** to make the Activities completely safe.
